# IMPORTANT CEU INFORMATION



## **CEU Approval Information & Process: Please read carefully.**

Continuing education credits can be earned for both CRCFA and NHA licenses.

In-person training sessions will be submitted for approval to the South Carolina Board of Licensed Health Care Administrators (SC BLTHCA) via CE Broker. Live webinar trainings will also be considered as in-person training credit as they are live and interactive and require your camera on and participation. Those virtual sessions are submitted to the National Association of Boards of Health Care Examiners (NAB) for approval. This is because NAB approves various states, allowing individuals from across the country to access these virtual trainings. SCALA will enter all attendee hours in the CE Broker database as required by the Board of LTHCA or NAB, provided that the correct information, such as name and license number, is provided to SCALA. Participants will receive a certificate at the end of each class or webinar, either in person or via email, as proof of attendance.

**Adding NAB CEUs to CE Broker: If you're participating in a webinar approved by NAB and want it to be counted in your CE broker, simply upload the certificate we provide you at the end into your CE broker account. Since NAB approves the webinar, we can't upload it directly into your CE broker. However, CE broker/BLTHCA will accept it, so you'll need to upload it directly into your account. We recommend having an NAB account (and you can create one for free) because many classes with us or other organizations are approved for NAB hours, providing another opportunity to track your hours. Unfortunately, both systems don't communicate with each other, but you can always print any NAB certificate and upload it into your CE broker when renewing your license.**

## **Accessing the live webinars:**

Webinars will be conducted on Zoom. Three days before the scheduled webinar, SCALA will send you an email with the link and any necessary access codes for logging in. Upon joining the class, log in and your name will be displayed, which serves as our attendance record. We kindly request that you have your video on as proof of participation, but ensure you have the controls to mute yourself or stop the video as needed. If you haven't received the access info by the day before the CEU class, please contact the office promptly so we can send it to you. Please avoid waiting until the morning of the webinar, as it tends to be quite busy, and we may not receive your request before the class starts.

## **Education Policy**

To participate in either the live webinar or the in-person class, you must remain in the session.

This program complies with the Board of Long Term Health Care Administrators' and NAB rules. To receive CE credit for the remaining time, you must work full-time and participate on time in live webinars. Unfortunately, you won't receive a refund for the class or credit to take another class. It's your responsibility to stay involved for the entire allotted time for the seminar. No exceptions will be made for any reason, and partial credits are not provided. Please ensure that you keep your certificate in a place where you can easily find it. 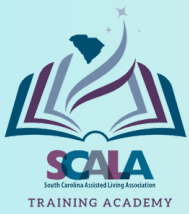
